Report of the President

Dear Members, dear Delegates

My report is basically for the second part of 2021, which was indeed a very busy time for WRRC International events.

Let me start with a big congratulation to all dancers, coaches, organizers, officials and supporters who contributed that we had a wonderful autumn season 2021.

Despite all obstacles we managed to organize almost all events and crown new World Champions in all our disciplines and categories.

The vicinity of World Games and a big competition break brought us new dancers in Rock'n'Roll Main Class Free Style and I just hope this trend will continue.

But it was also a tough time for the organizers and participants. Covid-19 rules, infections, lockdowns, quarantines they all affected the number of dancers on the events, the logistic was quite challenging, the cancellations happened until the last moment and the number of dancers on some events dropped drastically for these reasons.

Luckily all the troubles didn't 'scare' the organizers, we have a full calendar for 2022, with less events in spring but a huge autumn season again. However I must comment – year after year the same countries and same organizers take the challenge of organizing international WRRC events. Somehow I feel all countries should organize at least one event every two years.

In the autumn of 2021, also the Presidium focused mostly on upcoming events, daily business and on the tasks connected with GM decisions.

We continued with our regular online meetings and as I have already said they proved to be efficient for daily tasks, on the other hand for the strategic approach and bigger projects the virtual meetings are not the best solution.

We reviewed our rules and other documents, prepared some changes but decided to wait for major decisions and projects for the time after the GM and elections.

We managed to have our first strategic brainstorming session in Warsaw in September and the second one this January in Zagreb. If we are re-elected as a team, we will prepare new projects already this year.



We carefully read the comments, remarks and suggestions from different member federations and we will do everything possible to improve in the next term.

My activities inside WDSF Presidium were limited to online Presidium meetings, because we haven't met in person since the start of Covid-19 pandemic. With new elected WDSF Presidium we mostly focused on Olympic charter and Breaking and on World games for other disciplines, Rock'n'Roll included. In some countries the cooperation between WDSF and WRRC national member bodies remains challenging. In the near future our role inside WDSF should become bigger and more transparent with clear joint project, not only limited to the World Games.

I would like to use this opportunity to thank all the Presidium members and members of the commissions for their hard work done in the last four years. Even if our perception and vision is not always the same, we all strive for better future for our dancers and our federation. Different view on the same topic gives us more possibility to see the whole picture.

Without Kresimir Bosnar in the office, our daily business couldn't run as smoothly as it had and even when he should have been on sick leave he helped us to be on time for everything regarding the autumn competition season. Thank you, my dear friend.

As I wrote in my candidacy letter, it started very promising in 2018 with our trip to USA, followed by China and SAP World Cup finals, but...

I'm sure we will shortly be able to restart all our activities regarding our expansion, which is not only limited to new continents and new countries, but also focused on new dancers in existing member countries, new competitions, wider recognition of our sport in the community and on the sport map and bright future for all of us.

Expansion and Marketing

This time we are preparing our reports only 6 months since the last General Meeting and this is the reason why I would like to focus more on the plans. However, before that it is important to mention that the end of 2021 was a gulp of fresh air as we witnessed offline competitions come back on real stage which also allowed to put some life to our social media activities and sponsorship negotiations. What is more, some countries where we planned to work on corporate clubs lessened restrictions and we could start this year with ready-to-start plans for Armenia and Hungary.

Ahead is the year when the new reality in Expansion and Marketing is already a given, as well as the year when, if re-elected, I plan to work on the following.

Expansion

This year we will be able to show our Expansion results at the World Games where the couples from Australia, India and Mexico are qualified. We will also take an opportunity of this big international event in the USA and hold a WRRC summer camp in 2 locations – Miami and Los Angeles. This camp is organized with the managing support of the WRRC, Expansion coaches and American leaders willing to develop ARR further in the country (with own ARR past experience). Marketing part, which is not only important in terms of promotions but in terms of future classes, will include express research on the market, analysis of the competitors, segmentation of the audience (express customer development) and an express strategy with visualization and realization of marketing operations.

I will continue making the database of possible working contacts in the new countries where ARR&BW are not developed and organize activities – online or offline depending on the circumstances – in order to increase the number of the members. I always welcome our members' initiative in this question too.

The big help for the Expansion will be our mutual project with VP for Education Katalin Kis when we will record online video classes for all (mass oriented) and when online video classes being produced by Katalin Kis and VP for PR&Communication Bartlomiej Kobylanski are ready for use (by summer).



Hopefully, there won't be new obstacles to continue the realization of the corporate clubs project so that we can develop ARR as a mass sport in new and existing member countries, as I personally believe it is the basis for the stable development including Main class couples creation and preparation. Mass sport together with amateur/professional sport is the best combination we can see in other sports examples. However, in order to make this system work there should be a complex education and marketing support too.

Marketing

As regards the marketing part, I would like to point out that gradually we built good social media presence (organically without paid activities), unified the visualization of the WRRC brand and, finally, we are at the stage when we need to get back to the new marketing strategy which will answer modern trends and, most important, the request of the target audience.

Inside Presidium we have various ideas about future paths and necessary changes in the positioning of our sport, its contents including naming, music etc. Also, there are various propositions coming from our members which are also valuable. Nevertheless, as a marketing professional I must say that our ideas, hypothesis, propositions may only work if tested on the audience and proved through research. After the analysis and testing the next step is the strategy where communication messages, brand strategy (attributes, feelings) and promotion strategy are outlined with budget allocation. The reason why I'm writing it here in details is that many federations don't organize marketing inside but only do some quick actions on development of this or that product (school/class/competition) and it is difficult to understand which kind of job is being done by marketing in the WRRC. Nowadays there is a plenty of possibilities for almost anyone to try oneself in digital marketing instruments and with this the possibility to lose the budget on such instruments increases too.

Being an international federation, we face the biggest challenge as we work with the worldwide audience which much more vary than anywhere. In my opinion we have only one right way to work – to take the strategic plan, and that what the WRRC will do this year. In cooperation with PR&Communication I also plan to raise the number of publications on our sport internationally as part of marketing exposure.

Last but not least, I will continue on attracting new sponsors, and for this year we will have the Gazprombank as direct sponsorship and Rusatom as sponsorship for corporate clubs development.

During the General meeting I will hold a workshop on the basics of sports marketing and would be glad to answer your questions.

PR and Communications

As a Vice President for Communications, I recognized that the changes that are needed in our federation must be consulted with representatives of our national federations. In order to do so, the WRRC vision channel was created, where together with President Miriam Kerpan Izak and Vice President Marina Kalacheva, we discussed the way forward. Through these surveys and communication, I proceeded to draft the vision of the future and the necessary changes. The draft for change deals with many aspects including mass sport, elitism of MCFS categories, simplification of rules, empowerment of the federation, Extreme Dance Sport project. We discussed many of these ideas after the GM in Warsaw at a special presidium meeting and during the presidium meeting in Zagreb. After consultation with the WRRC presidium, all the ideas were gathered and will be introduced gradually and comprehensively. So, 2022 should be a year of development and of important changes.

One of the elements I worked on in 2021 was the development of the sport through Rock 'n' Roll Acrobatic classes. This project involved meetings between 50 coaches from 4 countries. These meetings were aimed at creating an educational program for sports classes in the first stage of primary school. This program will consist of an educational document and video modules for teaching Rock 'n' Roll Acrobatics in primary school. This material should also be helpful for clubs that are starting to work with RR. A final, concluding meeting will be held in Bratislava in February 2022.

In 2021, I organized a General Meeting in Warsaw with representatives from 18 countries. During this meeting, I managed to ask a representative of the EU Sports Commission to conduct a workshop on funding opportunities for sport in national sports federations and clubs. I consider the meeting of members of our federation to be a success because, despite restrictions related to the C19 pandemic, it was possible to hold a full-scale meeting.

Working to support the activities of our dancers through wrrc.shop we managed in the term April 2020 - May 2021 to donate prizes of 2200 euros to the competitors.

In 2021 I attended 10 meetings of our Presidium during which we made decisions related to WRRC current affairs. At the end of 2021 I communicated with all the organizers of the current year's competitions to complete photos and video. At the end of 2021 we made



the decision to change the professional person in charge of our social media, and working with Alexander Geifman we will try to improve the wrrc instagram, facebook and youtube channels.

As a member of the presidium of our federation I thank you for your trust and good cooperation. I hope for many positive and relevant changes in the future.

Education

This was a year of plans and redesigns. After realizing the lockdown in the whole worldin 2020, we couldn't imagine that it would continue in 2021 as well. We really believed in the opening and postponed many events and projects to 2021.

Unfortunately, we had to stay in the virtual life in spring and most of our projects were destroyed again.

Two main projects were planned from 2020 and postponed again:

- 1. InterRock2021 camp and WRRC congress (28.06.2021 04.07.2021, Hungary)
- 2. Educational materials

It was a connected project of InterRock because most of the recordings were plannedto be made during the camp. Unfortunately, this project is also further postponed.

I created a structure of online coach seminars, but the start of this program is stilldelayed. We have some difficulties with organizing these courses:

- financial and technical questions,
- language problems of lecturers,
- best timing of courses (we had competitions at all weekends in autumn).

Preparations were made, so we can start these online-seminars soon. We had some success in 2021:

- 1. Teaching material was compiled in Australia and India. The program is to be taught in private and public schools throughout Australia and India, and this plan has been thoroughly checked and found unique and most effective. The teaching material is in harmony with most of the state granted programs.
- 2. We coordinated online the preparation of the couples from 3 new continentsto the Online World Cups. Australia, Mexico and India participated in these online competitions and qualified to the World Games 2022 with the help of curators.
- 3. Statistics were made about the education in different countries and I started to collect educational materials from international experts.

Despite the impossible circumstances, a great deal of background work has been done, with which we will hopefully soon be able to show spectacular progress in the field of education.

This report is the last of my first period as vice-president in charge of legal affairs.

As I already wrote in my candidacy letter, I took great pleasure in accomplishing my mission, all the time in the interest of the dancers and our federation.

The 2021 competition year will have been very short since it was concentrated between the end of June and the end of November. But competitions could take place and it was the most important for dancers and sport.

Regarding the regulatory documents, the proximity to the World Games has somewhat frozen the most important changes. Only clarifications and additions (New categories) have been done.

In fact, we had the pleasure of seeing the Boogie Woogie Rising Stars project come true. This new category, which was to promote and facilitatethe integration of new dancers from new nations and new continents, hadbeen temporarily stopped because of the Covid crisis.

The work of the Boogie Woogie commission under the leadership of its commissioner Aina NYGARD has been remarkable and I wanted to express my gratitude to them for the sharing we were able to have to finalize the rules documents. These rules are now available on the WRRC website.

Dear all,

In the beginning of the year 2021. it was still uncertain how the situation will affect the competitions we had planned. In the first part we managed to continue with online competitions series which gave the dancers the opportunity to continue training and preparing for the events. Second part of the year was really the great beginning of recovery of our sport mostly because we had great organizers which managed to plan and bring to life live competitions for our sport. On this I'm really grateful.

WRRC Presidium continued the constant communication and activities and I'm proud to be one of the persons who participated in all the things we managed to achieve in these challenging times.

Based on the insides of our sports from Presidium members, coaches, judges, observers and other persons involved in BW and RR, we got a base for most important guidelines, from which we will make foundations for BW & RR Future Vision.

During the 2021. WRRC organized:

- 19 Rock'n'Roll Events (7 online and 12 live)
- 7 Boogie Woogie Events (3 online and 4 live)
- TOTAL OF 26 Events

On these events we used all 55 RR Judges and 16 BW Judges and all 12 RR & BW observers.

We all know that Online competitions can't replace live events, but the next step is to use them for our dancers who are still unable to travel frequently and participate on live events.

During the 2021. Sport commission continued to work and to follow the situation with the rules and remarks and questions from members. A new category Quattro formations RR was presented on several competitions (World Championship and World cup).

BW commission managed to improve the rules for BW and also made a complete document for new Rising star category which will start in 2022.



In the end we can conclude that both disciplines survived, hopefully, worst period that we all passed through. During the year we had realized that some parts of the rules were not clear enough, so we tried to make adequate clarifications and corrections and hopefully made them better and more understandable.

During the year 2021 RR & BW seminars were held, both for all judges with exams for new candidates. All the judges who needed to prolong the license attended and we also have 5 new RR judges and 1 new BW judge. BW Commission introduced Online seminar for Dancers which received really good feedback.

At the end of 2021. we assembled the final ranking list for upcoming World Games in Birmingham USA. All the steps required from organizer of WG and WDSF are made, and all the athletes are announced in WG System. All the following information regarding the WG will be published as soon as we got them.

Presented evaluation of judges will be used in following period to create initial preview of the situation from which we will try to help judges to see on which aspect of the judging they should focus more, and what is their position inside the final score. We are planning to have feedback for all the judges 2022.-2023.

There are a lot of challenges while assembling the judging panels, taking into consideration a variety of different situation from one country to another and constant change in rules and regulations connected to pandemic. In the end we managed to have the needed number of judges for each live event, and for this I also want to thank our judges who really went through sometimes tough times just to come to competition and to return home.

In the end I would like to thank all our dancers, coaches, federation members and officials – without all of you wonderful people it would be impossible to keep our sport alive – so all of you deserve one big THANK YOU!!! A very special thanks goes to NJS RR & NJS BW group members and my colleagues in WRRC Presidium who have been an extraordinary support in this challenging years behind us.

I hope we will soon manage to fully revive our "old" normal and continue our lives and sport careers even better than before.

Finance Director

Dear delegates and member countries!

After this crise with corona we find a very new style to still activate our couples with the online competitions, however this competition where expensive and we used our remaining money from Sap sponsor money. But it was worth it. The viewers on You tube increased in an incredibly positive result, especially when we had combined events with BW.

Cause of corona we had in our live events also many cancellations and we helped our organizer which really had a huge percentage of cancellations.

Last year we had a challenge with the Banks in Switzerland in the beginning of the Year our long-term Bank Raiffeisen terminated our relationship, and we had to look for a new bank. They did not give us any reason. Together with Susi Huber we managed to find a new account in Post finance, and we were relied with this problem. However in the beginning of July we got again a new termination from Postfinance , and now it went hard to find a new bank. We asked help from WDSF and they gave us the contact names for UBS corporate bank. With this bank we already had a request from the beginning of the year, but we postponed it because this is more a business bank, and the costs were high. However, this was now the only opportunity to have a bank relationship in Swiss.

All these problems made of course an excessive cost for us in 2021, and much work for the auditors and me to follow all these bank flues.

We had also to use my personal credit card so that we could pay all our costs for streaming etc. for our OWC competitions.

From the beginning of 2022, we have now 3 credit cards, one in the office, one for the President and one for me.

The result from 2021 looks not so bad but we have to be carefully with our transactions and payments for 2022, so we can establish our accounts again.

Starting fees from competitions 2022 will stay for the organizer, this for a helping hand for the competition organizers.

From the Academy account, we spared the whole sum of the money for 2022.



I still want to point out some small things: the same as I mentioned last year

- For the prize money, everybody must fill out the form for the prize money in advance and written in such a letter and numbers that we can read it clearly.
- If it is not done, we will not pay the prize money. This year we had a huge job at the competition and afterward. Please remember is not only one couple who are getting this money and it is a lot of money and transactions in December and when the money comes back cause of incorrect data, we really do not know from who this money is returned from, also the expenses from such a transaction can cost us 50-65 Eur / each
- For WCh and ECh, we are sending reminders out to each federation these claims must come to us before the closure of the year, these countries which did not send the claims in time cannot ask for the money for the previously years

The registrations fees must be paid from the member federation, not from couples.

All the claims from You to WRRC must be correctly fulfilled with the claim from WRRC and send to <u>financedirector@wrrc.dance</u>. Please note that we have new claims for each category. which you can find on our website.

From our members from the other continents, it is hard to transfer the money through the bank, so we still have to accept that most of them are paying their membership fees and registration to us in cash, and in the same way if we have something to pay them from the expansion budget or world championships in cash.

I hope you will understand that we must move to the transactions through the bank.

WRRC address is in Switzerland even if the presidium members have their own addresses, our main address stays in Switzerland.

I want to thank our auditors Gritli Ramschag-Wollein and Daniel Fuog for good cooperation. It is difficult to find some left overtime for all three of us.

A big hug and thank you also for Susi Huber who managed all our bank relationships, she is also our contact person for our Accountor.

Our books are checked every year from an authorized accountant in Switzerland and they are also doing our declaration for taxes in Switzerland.

I want to thank all the Presidium members for this common year, we had so much work at our online meetings that none of the meetings where boring! I am full of energy and motivation for our sport even in the future!!!

Report of the Boogie Woogie Commissioner

The main focuses in 2021 have been to adjust to the pandemic situation, and to look at the possibility to continue with competitions and seminars at the same time. We were very happy that 3 of the live competition in autumn could go as planned, and we are so impressed over the work done by the organizers. All the planning and adjustments that they had to do in short time because of the Covid, made the organizing of the competition a lot more complex than normally.

The online competition demanded an adjustment and a new concept for the Boogie Woogie. The showcase competition gives a completely different feeling than the normal competition with improvisation and the music selected directly. It has been interesting to see the different adjustments the couples have been doing, and it's good that we now are back to live conditions, so the couples can dance and practice together, and that we'll have back the complexity and soul Boogie Woogie with live improvisation on the stage.

It has been organized 3 online competition and 4 live competitions in Boogie Woogie in 2021.

Thank you to all the participants at the online and live competitions in 2021.



The regulations in Boogie Woogie are now well developed and familiar among the dancers, trainers, and judges. We think that we now have rules representing both the complexity of the dance, and at the same time give places for all the different styles in Boogie Woogie. There where therefore no adjustment in the Boogie Woogie regulations in January 2022.



The Boogie Woogie Commission have organized online seminars for judges, observers, and trainers in 2021. The online seminars worked well, and for the future the judges would like to have both online and live seminars. The seminars for trainers were with a large number og participants, and this give the possibility for a closer dialog between the Boogie Woogie Commission and many trainers from the different countries. We would like to continue to have seminars like this.

OBJECTIVES & ACTION PLANS FOR BOOGIE WOOGIE 2022

Regulations

The regulations in Boogie Woogie will be evaluated, but we hope for as less as possible needed adjustments, so that the couples and trainers know the details in rules and can develop together with those. We hope the focus instead will be to exchange knowledge to new couples and new nations.

Seminars for the dancers and trainers

We started up this year with a seminar for the dancers, and we had a very good ambiance and good feedback on this. We would like to continue to plan and develop this concept, so we can have seminars regular for both dancers and trainers. One of the goals for the Boogie Woogie Commission is that all the knowledge will be shared with all the couples, and that all the dancers can ask questions to better understand the details in the competition rules, and have proposals for adjustments in regulations etc.

Judges and observers

Seminars, feedback, and trainings for the judges will start with a seminar for both the licensed and new judges. We hoped for a live seminar for the judges so the seminar was therefore postponed from the normal date, but it's now decided that the first seminars in 2022 will be online. Meeting and seminar for the observers will also soon be added to the calendar.

Rising Stars

One of the main focuses this coming year are the Rising Star Competitions in Boogie Woogie. We hope that this category will give a possibility for all the Boogie Woogie dancers on a beginner's level or/and the Boogie Woogie dancers that mostly have been dancing socially in both existing and new countries, to fast also enter the competition area in Boogie Woogie. We are still looking for organizers for these events, and hope that we'll have organizers from both big and smaller events will add this competition form.



Thank you to all dancers, trainers, judges and the Presidium for discussions and exchanges also in 2021-2022. Thank you to all dancers for continuously developing the Boogie Woogie as a dance. Special thanks to Pirjo Koivula and Leo Beck that has been working together with me in the Boogie Woogie Commission. I'm looking forward to that we'll also in 2022 will continue together to develop the Boogie Woogie in a good way.

Report of Anti-Doping Commissioner

Because of the COVID 19 situation and the related changed tournament events, no doping controls were carried out in 2021.

This year we believe that we can return to normal sports activities, which is why doping controls at WRRC tournaments are planned again in 2022.

At the last General Meeting 2021 in WARSAW, we had an Anti-Doping focus with the lecture by the **Chairman of the Anti-Doping Commission of the WDSF Herbert WALLER** about the Anti-Doping Code of the WDSF which he wrote.

The new WDSF Anti-Doping Code was prepared, discussed and decided by the WDSF in 2020 and came into force on January 1st, 2021.

The WDSF Disciplinary-Council Code and the Internal-Dispute-Resolution Code of the WDSF also had to be adapted and revised.

I would like to single out and repeat a few important points of his presentation.

What is new for us is that we now differentiate between three groups for our dancers:

- International Level Athletes
- National Level Athletes and
- all Other

The WRRC Presidium decides who is counted as an International Level Athlete

International Level Athletes must submit their **Therapeutic Use Exemption (TUE)** requests to the **WDSF Anti-Doping Commission** for review and approval. This must be done as early as possible, because retroactive TUE's are not possible. Emergency requests must also be sent to the WDSF before the start of the tournament with appropriate justification.

National Level Athletes must submit their TUE's to the appropriate **National Anti-Doping Organization (NADO)** and retroactive TUE's are also possible.

International Level Athletes are therefore under particularly strict observation.

The WDSF Anti-Doping Code, which is based on the rules of the World Anti-Doping Agency (WADA), requires so-called "target testing" when planning the test. It means



that we test those target groups and sectors in which doping is more likely to be. It is also about testing the dancers for whom doping could be an alleged advantage.

Doping is never really an advantage, it is always a cheat in sport,

I am also happy about the numerous questions from dancers, trainers and officials all year round and when I can help in anti-doping matters.

Motions to the Annual General Meeting 2022

Motion 1: Indication of Observer's deduction in Final heat results

- **Problem:** It is currently not possible to see deductions made by the Observer (e.g. on acrobatic elements) during an ongoing competition. In qualification rounds usually the results are published on paper, including the Observer's ruling on acrobatic marks. This way, coaches and athletes have the possibility to talk to the Supervisor or Observers and can get clarifications on the decision. After finals rounds however, in many cases those officials are unavailable for questions because they may have already left the location. Detailed results are only published online on the WRRC webpage hours after the end of the competition, making an immediate intervention or appeal impossible.
- **Objective:**
 - Creating a possibility to indicate execution errors and deductions immediately. 0
 - Making deductions transparent and improving the understanding for/of participants. 0
 - Improving the communication between officials and athletes/coaches in case of 0 Observer deductions.
 - Minimizing the risk of failure or at least offering the possibility to reassess errors. 0
 - Implementing an open error culture. 0
 - Creating learning effects and improvement for athletes, coaches and officials likewise.
- Motion: Implementation of the Observer's ruling into the indication of results in Linum software immediately after final heats. Adjustment of the WRRC competition software and indication of points to give instant feedback on deductions of the acrobatic score, i.e. show "Acrobatic 1: OK ; Acrobatic 2: -1.0 p" after respective heat.

Motion 2: Clarification on protest procedure / Video Review

- Problem: In the Minutes of the General Meeting 2021 the option to raise a protest during a competition against scoring decisions was mentioned. The WRRC Fee Scale was adjusted accordingly. However, it has not been clarified in the WRRC Tournament Rules how such a protest can be registered during a competition and who is in charge. Also it is not clear who can raise such a protest.
- Objective: Establishing a possibility to raise an immediate protest against a judging decision during an ongoing competition. The WRRC purchased video equipment prior to the pandemic to record video footage of the shown performances. There has to be an option for coaches to raise protests during competitions and demand a video review in case of incomprehensible Observers decisions or obvious errors.
- Motions:
 - 1. We call for a clarification on the protest procedure and to have a description thereof implemented into the "Tournament Rules", as well as defining which representative from the officials board is in charge and who can call a protest and/or video review from the coaches and athletes side. In order to prevent long interruptions during competitions, this procedure should be clearly outlined.
 - 2. We call to assign the Sports Commission to establish a video review procedure. These kind of technological assists have been used and proven to be very successful in other technical-compositional sports (i.e. Olympic gymnastics). An implementation of this option in all rounds from the semi-finals onwards can be discussed.
 - 3. The description of these procedures are to be published in the "Duties of the Officials" and /or "Overall rules of competition".

Motion 3: Limitation of participants per nation in final rounds of international Championships (Continental or World Championships)

- Problem: In view of the WRRC Expansion, the goal of founding new national associations overseas and becoming an Olympic sport eventually, our sport has to be more diverse and open to anyone. Several categories in Acrobatic Rock'n'Roll have been strongly dominated by several nations for years. Semifinal and final rounds are usually occupied by representatives from one, or a maximum of two or three nations on a regular basis. This monotony and lack of variations are jeopardizing the diversity of styles and ideas, and is unattractive for non-expert spectators.
- Objective: Corresponding to the idea of the World Games, the variety and diversity of nations and styles in international competitions, and especially in the finals of Continental and World Championships has to be guaranteed. In order to provide access for athletes to national sponsorships, they have to receive acknowledgement on the highest levels of their national Olympic associations. This can only be achieved if athletes are even given the chance to reach high-level competition results. Therefore the access to finals for more than a few nations has to be granted.
- **Motion:** The number of participants in Continental and World Championship finals should be limited to a maximum of three representatives per nation. That means from the result of the semifinal only the best three participants per nation are promoted to the final. The final list starts with the best couples until the seven spots are filled. This procedure is paralleled by several other Olympic sports like artistic gymnastics.

Motion 4: Preservation and additional rating of Bettarini

- **Problem:** Flying acrobatic elements in MCFS category are limited to two possible entrance techniques (Bettarini, Staff). The learning procedure involved for a Bettarini technique is challenging and demands additional skills from athletes. Bettarini can only be found in our sport and should be preserved as a typical and unique Rock Acrobatic element. It represents acrobatic variety in the highest Main Class categories. In MCCS this element is already rewarded with an additional bonus of 2.5 points as acrobatic entrance. In MCFS so far no additional points are awarded for Bettarini yet.
- Objective: Acknowledgement and preservation of Bettarini as a unique and traditional Rock'n'Roll Acrobatic element. In Main Class categories the value and rules for Bettarini should not be handled differently, therefore an alignment of the Code of Points in MCCS and MCFS is needed. This will also compensate for the additional effort needed during the learning and training process. Last but not least, it improves the attractiveness of our sports by more acrobatic variety in MCFS.



Motion: The execution of Bettarini should be made obligatory for all participants in heats starting from semifinals in Main Class categories. In MCFS, Bettarini should be rewarded with an additional points score as acrobatic entrance for the first time performed in the program.



Entrance Value: 2,5 points bonus (only once – for the first one during the program)

cf. WRRC Acrobatic Safety Levels, TR 0005 1.0, Entrance MCCS, p. 43

Motion 5: DRBV requests the general introduction of a time limit for speaking at the AGM

DRBV appreciates the passion and the deep fact-based discussions of the WRRC members during the AGM. However, particularly in last year's Annual General Meeting, the assembly could not be executed in the scheduled time frame. This was partially also due to long discussions and long individual statements of applicants of the motions. Even though the presidium had decided to limit the time for each speaker, not all motions could be decided by all members, as many members had to leave the meeting before it could be concluded. This is considered particularly critical, as they have not been able to execute their responsibility on deciding about motions as per the statutes.

Therefore, DRBV introduces the motion to add to the Statutes of WRRC within paragraph 10, item 3:

"The speaking time of every participant is limited to 5 minutes per item discussed."

An operational side note: A publicly shown timer can help to execute this procedure.

Motion 6: Following the same reasoning of Motion 5, we believe that a neutral Master of Ceremony could beyond the time limit introduce a balanced and neutral discussion platform. Of course, it will be legitimate that the presidium will do preparation work with the MC.

Therefore, DRBV introduces the motion to add to the Statutes of WRRC within paragraph 10, item 3:

from: The President of the Presidium shall take the chair during the general meeting. to: An official master of ceremony shall quide the meeting on behalf of the Annual General Meeting. The election of this master of ceremony should be decided by the AGM 2022 and introduced to the statutes accordingly."

Motions 7: Election of a Master of Ceremonies

Upon approval of the AGM for Motion 6, a process to select a Master of Ceremonies has to be defined by the AGM. DRBV proposes two motions for this process:

Motion 7a: The AGM of the preceding year elects the Master of Ceremonies for the AGM of the following year.

Motion 7b: A pool of Master of Ceremonies will be elected (e.g. 3 honorary members) and the presidium rotates the appointment of these AGM for every year.

Motion 7c: WRRC will open a candidacy for a Master of Ceremonies with the announcement of the general information about the AGM and the presidium will elect from incoming candidacies. The candidacy should include a short CV showing experiences in leading larger forums as well as respective language skills.

In last 8 years a lot of things happened. Our sport and all disciplines went towards higher sports levels. Last 2 years were especially challenging with pandemic situation and everything connected to it.

Personally, I think we are at the breaking point for our sports. In next 4 years it is crucial to find a way how to continue connected to current and possible future situations and scenarios. One of big goals will be finding a way how to help our members where number of dancers, club, officials and coaches dramatically decreased.

In this way I'm thinking of continuing Online series of competition, but with clear path which will enable it like a platform for all the dancers to participate in our sports.

Second important thing is a big review of our current rules. During the years we tried to find good balance between all the feedback from our members, judges, dancers, coaches and other active persons in our sports. Now it is the time to make a change! We should strive towards rules which will be more understandable and clearer for our dancers and coaches and at the same time valid for all the goals we still have with approaching a step closer to our dream of being a sport at the Olympic games.

This all will not be an easy task, but I believe that we have many persons which will be willing to help in our work through various positions in different commissions. With the experience from all the past competitions (live and online), we will find a new model which will be modern and appealing to younger generations, more interactive for our spectators and audience in the halls and more media exposed. In last few Presidium meetings we discussed a lot about the future vision of our sports and possible ways how to improve it. I strongly believe that the teams we have will do it in next period!

To summarize, my program for next 4 years is consisted out of:

- Big review of **NJS** and all the rules connected to feedback we got from all instances
- **Implementation of analysis of judging** (as presented in last GM) with clear goal of giving the judges better insight to their judging and positive way of improving the quality of judging for our dancers
- Improvements in data presentation on competition both for dancers and audience
- Further analysis and improvement in Safety levels
- Making **Online competitions** a foundation for new countries and dancers who, for any reason, can't participate on live events combination of live, online and mixed competitions
- **Constant contact** to all our members and even better cooperation on preparation of definitions and descriptions

I'm willing to put my 31 years of experience into a WRRC. With good ideas from all national associations we can make our sport even better. This position brings great responsibility towards all the people in our sport and I will try to keep up to that demand by making our sport better for audience, dancers and all persons involved regardless to the future situations that will surround us.
